- Should be established in the identified / Target areas for Seaweed Nurseries allocated in the City / Provincial Fishery Offices of ZC, ZSP, ZDN, and Isabela City
- Must follow the design and program of work of the project and be free from defects and damages

- 1. The Bureau of Fisheries and Aquatic Resources Regional Office No. IX, through the General Appropriation Act CY 2023 intends to apply the sum of two million six hundred sixty-six thousand pesos only (Php 2,660,000.00), being the ABC to payments under the contract for "Job Order-Labor Service Only for the Installation of Raft method (Alul), Long Line Method and Spider Web Method use for Distribution for the Support Intervention to Increase Seaweed Production with Priority Area Affected by the Implementation of Closed Fishing Season in Region IX for CY 2023". Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
- 2. The Bureau of Fisheries and Aquatic Resources Regional Office No. IX now invites bids for the above Procurement Project. Delivery of the Goods is required by two hundred thirty working days (230 working days). Bidders should have completed, within 2 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- a. Under Section 23.4.1.2 of the 2016 revised IRR of RA No. 9184 exists:] Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.
- 4. Prospective Bidders may obtain further information from the Bureau of Fisheries and Aquatic Resources Regional Office No. IX, and inspect the Bidding Documents at the address given below from 8:00 am to 5:00 pm.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on May 29, 2023, from the given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 1,500.00. The Procuring Entity shall allow the bidder to present its proof of payment for the fees.

[NOTE: For lot procurement, the maximum fee for the Bidding Documents for each lot shall be based on its ABC, in accordance with the Guidelines issued by the GPPB; provided that the total fees for the Bidding Documents of all lots shall not exceed the maximum fee prescribed in the Guidelines for the sum of the ABC of all lots.]

- 6. The Bureau of Fisheries and Aquatic Resources Regional Office No. IX will hold a Pre-Bid Conference on June 5, 2023, at 2:00 o'clock in the afternoon at BFAR BAC Office, R.T. Lim Boulevard, Zamboanga City, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before June 19, 2023, at 10:00 o'clock in the morning. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. Bid opening shall be on June 19, 2023, at 2:00 o'clock in the afternoon at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The Bureau of Fisheries and Aquatic Resources Regional Office No. IX reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
